

Service Animal Form



A service animal is defined as a dog that has been individually trained by a professional organization or a qualified individual that specializes in service dog training to perform a task that assists a person with a disability with a need related to that disability.

A qualified service animal may fly free of charge, but it must be approved by Air North in advance. Please complete the form below and submit it to serviceanimals@flyairnorth.com 14 days prior to travel. Requests must be submitted a minimum of 48 hours in advance. Once approved, you will be provided with documentation that you will need to keep with you for the duration of your travels. Even if it was previously approved, your service animal may be refused travel if you do not have the required documentation with you.

D · Animal Training

The service animal must be fully certified in writing as having been trained by a professional service animal institution or qualified individual. Proof of training must include an identification card or other document issued by an organization or person specializing in service dog training that identifies both the person with a disability and their service dog, and in the case of any service dog that is not a guide dog, an attestation by that organization or person specializing in service dog training that:

- the service dog has been individually trained by that organization or person to perform a task or tasks to assist the person with a disability with a need related to their disability;
- a clear description of the task(s) the dog has been individually trained to perform to assist the person with their disability-related need(s);
- the credentials of the trainer(s), including any qualifications, certifications and affiliations with professional service dog organizations such as Canadian Association of Service Dog Trainers and the Canadian Association of Guide & Assistance Dog Schools; and a clear description of the specific content of the training program(s) completed by the dog, including the duration of the program, the goals to be achieved by the dog, the involvement of the handler, the assessment methods used and the assessment results achieved by the dog and its handler.

Details about the training and institution/trainer are required as Air North may need to confirm this information. Registry information alone is insufficient as proof of training. **Please email proof of training documentation along with this form when submitting your application.**
